\*All service levels start when job is ready for pick up.

### **Same Day:**

- Inside Core (Financial Center)
  - Called in before 10am, due by 5pm
- Outside Core
  - Case by Case (example: A job called in before 10am going to Portland will automatically be charged as a dedicated ASAP)

### **Rush:**

- Inside Core (Financial Center)
  - Called in after 10am, due by 5pm
- Outside Core
  - Case by Case

### **ASAP**

- Inside Core (Financial Center)
  - 2 hours to complete
- Outside of Core
  - 4 hours to complete

### **Dedicated ASAP**

- Inside Core (Financial Center)
  - 1 Hours or less to complete (15 minute Dedicated, No problem!)
- Outside of Core
  - Fast as possible, limited time frame, DIRECT DELIVERY (Fast & Immediate)
